With the support of industry member companies and individuals, PPEF provides college scholarships to promotional products industry employees and their children to support general studies and industry-related educational goals.

PPEF Mission

- 1978 Foundation was established with a \$10,000 contribution from Walter W. Cribbins Company employees in honor of their boss, Carl Rosenfeld.
- 1989 First 4-Year College Scholarships were awarded to six students.
- 1998 First Chairman's College Scholarships were awarded to two students planning to enter the promotional products industry after graduation.
- 2005 First One-Year College Scholarships were awarded.
- **2020** \$276,750 was awarded to 160 students.

History

PPEF 1989 - 2020

1,358 scholarships awarded

Cumulative total = \$2,448,000

Scholarship Programs

- Four-Year Scholarships for high school seniors or gap year students, any major
- One-Year Scholarships for current college students, any major
- Chairman's Scholarships for career candidates entering their Junior year of college, field of study must be related to the promotional products industry – sales, marketing, graphic arts, etc.
- Friends of PPMN Scholarship for industry employees only

- Scholarships are available to full-time promotional products industry employees or their dependent children.
 - Parent = parent, stepparent or legal guardian
 - Student is younger than 24 years of age
 - Exceptions to this age if you can claim the child as a dependent with the IRS
- Students must have a minimum GPA of 3.0 to apply.

Basic Requirements

- Must be attending college in the Fall of 2021 to apply for this year's scholarships.
- PPEF scholarships can only be used to cover tuition, books, lab fees and educational supplies.
- Use student name and email address to apply.
- Applications must be received by Midnight Central Time on March 15th.

Other Requirements

Four-Year Scholarships

- The Four-Year Scholarship for Academic Excellence and Achievement is awarded to students entering their first year of college. The merit scholarship is \$5,000, awarded \$1,250 annually for four years. The need-based scholarship is \$9,000, awarded \$2,250 annually for four years.
- PPEF awards 5 merit and 5 need each year.
- For renewal payments, a 2.5 GPA is required and industry employment must be maintained by the parent or student.

Four-Year Scholarships

- GPA official high school transcript required.
- ACT/SAT Scores optional for 2021. Attach copy if exams were taken.
- Financial Need attach copy of Student Aid Report (SAR). The SAR must have an Expected Family Contribution (EFC) number on it for consideration.
- Essay describe a meaningful achievement or a significant experience and explain how it relates to your field of study and your future goals.
- Resume school activities, community service & volunteer activites, church & civic clubs, employment information and other skills & talents (9-12 grades).

One-Year Scholarships

- Students must be attending a two-year or four-year accredited undergraduate college or university and taking at least 6 credit hours per semester.
- The need-based One-Year Scholarship is \$2,250 and the merit-based One-Year Scholarship is \$1,250. This is a nonrenewable scholarship; however, winners are eligible to reapply.
- Awarding 58 need and 57 merit for 2021.
- Includes 29 Named Scholarships
 - HPPA, NWPMA, PMANC, PPAChicago, PPAS and UMAPP
 - Others named for individuals who worked in the industry

One-Year Scholarships

- GPA official college transcript required.
- ACT/SAT Scores optional for 2021. Attach copy if exams were taken.
- Financial Need attach copy of Student Aid Report (SAR). The SAR must have an Expected Family Contribution (EFC) number on it for consideration.
- Essay describe a meaningful achievement or a significant experience and explain how it relates to your field of study and your future goals.
- Resume school activities, community service & volunteer activites, church & civic clubs, employment information and other skills & talents (last 4 years).

Friends of PPMN Scholarship

- The Friends of PPMN Scholarship is available to full-time industry employees only.
- The value of the scholarship is \$1,250.
- Only scholarship that can be used for undergraduate or graduate level course work.

Friends of PPMN Scholarship

- Essay This personal statement should describe your individual character and accomplishments, your educational and career goals, why you believe you deserve the Friends of PPMN Scholarship and why you need financial help to pursue your education.
- Resume attach a 1-3 page resume with education, extracurricular activities, volunteer activities and work experience.
- Financial Need (optional) attach copy of Student Aid Report (SAR). The SAR must have an Expected Family Contribution (EFC) number on it for consideration.

Chairman's Scholarships

- The Chairman's Scholarship for Promotional Products Career Candidates is awarded to college sophomores entering their junior year, actively pursuing a bachelor's degree in an academic field related to promotional products and expressing intent to enter the field of promotional products.
- The value of the scholarship is \$5,500, awarded \$2,750 annually for two years.
- Two Chairman's Scholarships are awarded each year.

Chairman's Scholarships

- GPA official college transcript required.
- Financial Need (optional) attach copy of Student Aid Report (SAR). The SAR must have an Expected Family Contribution (EFC) number on it for consideration.
- Essay three parts:
 - •Explain your understanding of the promotional products industry. Describe at least one instance when you encountered promotional products in a real-life situation and critique the item's use in that situation.
 - •Explain how studies in your current course concentration can prepare you for a career in the promotional products industry.
 - •How do you see developments in your primary field of study affecting the promotional products markets in the next five years?
- Resume attach a 1-2 page resume with education, extracurricular activities, volunteer activities and work experience.
- Letter of Recommendation college instructor or non-family supervisor.

- All applicants with completed applications will be notified by email around the end of May with the decisions.
- Recipients need to submit an acceptance letter or proof of enrollment, photo, release form and thank you letter to finalize their awards.
- Checks mailed at the beginning of August.
